**Superintendent's Report**

Lloyd Hall, Superintendent of Highways gave the Board Members a detailed report, which is on file in the Town Clerk's Office. Additional information that was not included in the report is as follows:

- Called Snyder Fuel to have the tanks fill before a price increase and Snyder Fuel said that the prices have dropped \$.30 in the last couple of days. Lloyd decided to hold off on filling the tanks. Lloyd ordered a barrel of hydraulic fluid.
- One of the trucks broke a line and it will take 40 gallons to fill that truck.
- He has Carbon Tech company coming in on Thursday, March 17, 2022 at 9:00 am to give a demonstration of the product. Lloyd said that he has people from other Town's coming in to see the demonstration.
- During the Snow Storm on Saturday, March 12, 2022 one of the serpentine belts went on a truck. The side by side is all back together and he put a heavier duty clutch kit in because they are trying to keep up on the maintenance with it.
- The guys are getting more comfortable in the trucks because they are going through them on a daily basis.
- The Town received a bill from Charlie Stahl regarding the plow that he has on hold for the Town. The Town Board agreed that they would go ahead and pay Charlie Stahl for the plow but minus the labor because he has not put the plow on the truck yet.

**A Motion** was made by Councilman Jaikin and seconded by Councilman Doerrer to pay for the plow that Charles Stahl is holding hold for the Town of Manheim minus the labor charges. Ayes All

Supervisor Haughton advised the Town Board that the Town made its last payment on the truck. Supervisor Haughton has been talking with Lloyd about the problems that he is having with the loader. Lloyd is going to get prices for a new loader and let the Board know.
